




% Of Ratings (2023)

- The percentage of ratings in the 2 to 3 bucket remained the same from 2021 through to 2023 with only one firm (Harbottle & Lewis) in this bracket.
- Conversely, the percentage of ratings in the 3 to 4 bucket increased slightly from 28.17% in 2021 to 29.58% in 2023. This is a representation of 20 firms in this bracket in 2021 and 21 in 2023.

The overall trend indicates a **slight decline in the proportion of law firms receiving the highest ratings (4 to 5)** from 2021 to 2023, suggesting that fewer firms are achieving top ratings in the industry.

Scores in the range of 1-2 stars represent the lowest quartile. Scores of 4-5 stars correspond to the highest quartile.

- Across all locations, the highest score by a parent firm is recorded at 4.65.
- A minimum score of 4.35 is required to enter the top 25% bracket.
- A score of at least 4.11 is necessary to be within the top 50%.
- To fall into the top 75%, a score of 3.83 is needed.
- The lowest recorded score by a parent firm stands at 2.6.

- Attaining a score of 4.4 positions you within the second quartile.

Google's rating system permits scores ranging from 1 to 5 stars.

- The highest achievable score for any office is set at 5.
- To be ranked within the top 25% of offices, a minimum score of 4.8 is required.
- A score of 4.4 is necessary to fall into the top 50% category.
- Offices need to score at least 4.0 to be in the top 75%.
- The lowest score recorded, considering offices with ten or more reviews, is 2.0, which pertains to the Hogan Lovells Frankfurt office.
- The median score for an office is identified as 4.4.
- On average, offices have a mean (average) score of 4.27.
